

## STUNT WARS POLAND on POZNAŃ MOTOR SHOW 2020

### COMPETITION REGULATIONS

#### GENERAL PROVISIONS

##### §1

Stunt Wars Poland Competition at Poznań Motor Show 2020 (further referred to as **Competition**) is open to all adult participants of Poznan Motor Show 2020 event (further referred to as **Event**) held from March 27 to March 29, 2020, at Poznań International Fair.

##### §2

1. Competition Rules (further referred to as **the Regulations**) apply to the Organizer, Competition Participants and their accompanying persons, regulate terms and conditions of participating in the Competition and rights and obligations of both the Organizer and Participants.
2. The text of the Competition Rules will be available at the Organizer's headquarters and on the [www.motorshow.pl](http://www.motorshow.pl) website.
3. Violation of the Competition Rules by the Participant or his or her accompanying persons may result in the Participant being disqualified and removed along with his or her accompanying persons from the Competition area by the Organizer.

##### §3

Only those who meet the conditions set out in the Regulations are entitled to participate in the Competition. A Participant who has failed to comply with the Regulations will be disqualified.

#### THE ORGANIZER

##### §4

The Organizer of the Competition is the Poznań International Fair sp. z o.o. with head quarters on Głogowska 14, Poznań 60-734 entered in the the National Court Register kept by the District Court in Poznań - Nowe Miasto i Wilda in Poznań, VIII Division of the National Court Register under the number 0000202703 and in the register of active VAT taxpayers - NIP 777-00-00-488, with share capital of 42,310,200.00 PLN.

## COMPETITION PARTICIPANTS

### §5

1. Every adult who has signed up for the Qualifications, qualified, and paid the registration fee can take part in the Competition. Minors may participate in the Competition only under the supervision of the guardian with his written permission and upon payment of the registration fee. The Organizer's employees and their spouses are excluded from the participation in the Competition.
2. Only participants who compete on motorcycles with at least 599cm engine capacity are allowed to take part in the Competition.

### §6

A person meeting the conditions of participating in the Competition specified in the Regulations who has correctly signed up for the Competition will be further referred to as the Participant.

### §7

Once the Participant has earned the right to collect the Prize, he or she becomes a Winner of the Competition.

## RULES OF THE COMPETITION

### §8

1. The competition is three-stage:
  - A. Qualifications (first stage),
  - B. 1st round of the competition (second stage),
  - C. Finals (third stage),\
2. Competition Schedule:
  - A. Until March 13, 2020 Participants can sign up for the Competition (§ 10 of Regulations),
  - B. From the day of February 19 to February 20, 2020, the first session of the Referees Commission will take place, selecting 10 Participants qualifying for the first stage of the Competition from among the Participants registered until that date,,
  - C. Starting from February 20, 2020, names of the first 15 Participants qualified to the first stage of Competition will be published on the [www.motorshow.pl](http://www.motorshow.pl) website. The Organizer will send an e-mail confirming the qualification along with reminder about registration fee payment to all Participants qualified to the first stage of Competition.
  - D. At the day of March 1 and March 14, 2020, the second and third session of the Referee Commission will take place, selecting further 15 Participants for the first stage of the Competition. All candidates will be considered during that session,
  - E. On March 20, 20120 a list of all Participants will be published on the [www.motorshow.pl](http://www.motorshow.pl) website. The Organizer will send a confirmation email along with a reminder about the registration fee payment to all 30 Participants qualified for the first stage of the Competition.
  - F. All Participants qualified to the first stage of the Competition have to pay the registration fee until March 24, 2020,

- G. March 27, 2020 is a training day, from 10:00 AM to 6:00 PM Players can get acquainted with the surface of the Competition Zone, train and place their equipment in the Competition Area. On the training day, Participants are obliged to follow the guidelines of the Organizer or the Referee Commission.
- H. On March 28, 2020, the first stage of the Competition will begin at 11 AM and last till 6 PM. Before starting their runs, all Participants have to attend the Briefing, where they will be informed about scoring rules, competition rules, and safety regulations. Absence during the Briefing results in disqualification.
- I. On March 29, 2020, between 11 AM and 6 PM there will be finals followed by a closing ceremony and handing the prizes over to the Winners.

## §9

1. Each of the Participants joining the Competition declares that:
  - A. His motorcycle is technically sound and does not pose a threat to the safety of the Participant or the safety of others - the technical condition of the motorcycle can be verified by the Referee Commission on the training day or during the competition (on the second or third stage of the Competition). If the Referee Commission finds that the motorcycle is not technically sound, the Commission may decide to disqualify the Participant with no refund of the registration fee.
  - B. His motorcycle has current insurance.
  - C. He is aware of the danger resulting from taking part in the Competition.
  - D. He consents to the free use of the image of the Participant recorded in the form of photographs or video footage and grants the Organizer a non-exclusive free license for the use of a recorded image with no territorial nor temporal limitations in the following ways:
    - a) Consolidation and reproduction by any known technique and dissemination in any form.
    - b) Uploading it to the computer's memory and to the multimedia network.
    - c) Multiplying copies of the recorded image.
    - d) Public exhibiting, displaying, playing, broadcasting and re-issuing, as well as public sharing in such a way that everyone can have access to it in the chosen place and time.
    - e) Posting and publishing in the press, on websites, posters and billboards, social networks.
    - f) Broadcasting in television and radio broadcasts.
  - E. The form of the above mentioned consent constitutes Annex No. 1 to the Regulations. The above mentioned consent is voluntary, but it's absence prevents participation in the Competition.
  
2. Participants:
  - A. Before entering the first stage of the Competition each Participant has to sign:
    - a) A disclaimer stating he is aware of the risk arising from taking part in the Competition and will not claim damages in case of suffering personal injury or death.
    - b) Consent to the use of the image, as set out in Annex No. 1 to the Regulations.
  - B. Participants has to observe flag signals:
    - a) Checkered flag – start and finish of a run.
    - b) Red flag – immediate halt of a run.
    - c) Yellow flag – technical break..
  - C. Participants must use the following outfit:
    - a) Homologated helmet.
    - b) Protective clothing – it is forbidden to take part in shorts or tracksuits.
  - D. Participants must not take part in the Competition under the influence of alcohol or drugs. Participants have to follow safety regulations explained during the Briefing
  - E. Participants must not ride their motorcycles outside of the Competition Area and the Participants Area.

- F. It is recommended that Participants have insurance against consequences of unfortunate events.

## QUALIFICATIONS

### §10

1. Participants are qualified for the Competition upon meeting the following conditions:
  - A. Sending a correctly filled Stunt Wars application form until March 13, 2019, completing the application, available at [www.motorshow.pl](http://www.motorshow.pl) that has to include:
    - a) Name, surname, nickname (optional), date of birth of the Participant.
    - b) E-mail address.
    - c) Place of residence / nationality.
    - d) Phone number.
    - e) Details of the motorcycle the Participant will be riding (brand, model, engine capacity).
    - f) Information on whether the Participant has a technical car or service tent and on how many square meters the car and the tent occupy if he has them. (Due to the limited space in the competition zone, the Organizer will assign a place to the Participant for his car or service tent. If finding such place proves impossible, cars can be parked outside the Competition Zone. Places will be assigned to the Participants in the order of their arrival to the Competition).
    - g) A short Participant's bio covering his experience, career, achievements, and sponsors.
    - h) High-quality Participant's photo, not exceeding 2 MB.
    - i) High-quality video footage of Participant's riding the motorcycle (raw, unedited footage is recommended), not exceeding 50 MB; the footage has to be 2-5 minutes long.
  - B. Signing this Regulations on March 27, 2020.

Erroneously filled or unintelligible forms will be rejected by the Organizer.
2. From February 19 to February 20, 2020 the first session of the Referee Commission will take place, selecting up to 15 Participants qualified to the first stage of the Competition.
3. On March 1 and March 15, 2020, the second and third session of the Referee Commission will take place, selecting up to 30 further Participants qualified to the first stage of the Competition. Selected Participants will take part in the first stage of the Competition upon payment of the registration fee. The Referee Commission will select Participants based on the following criteria: level of skills assessed on the basis of the attached video footage, competitive stunt riding experience, and achievements of the Participant.
4. In two sessions, the Referee Commission will select from 24 to 30 Participants qualified to the first stage of the Competition.

### §11

1. By submitting the application, the Participant declares that he has full copyrights to photos and videos submitted for Qualifications and that they do not violate any rights of third parties, including their personal rights. The Participant declares that all persons featured in the picture or video agree to make their image publicly available. If the submitted photo or video infringes any rights of third parties, including copyrights and personal rights, the Participant is obliged to satisfy any third parties' claims resulting from the violation of these rights.
2. By submitting a photo or video, the Participant agrees for it to be used for information and promotion purposes regarding the Competition and the Event

## **§12**

The Organizer will notify the Participants who have been qualified for the Competition about the need to pay the registration by sending an email to the Participant's address indicated in the application.

## **REGISTRATION FEE**

### **§13**

After receiving information about qualifying for the first stage of the competition, no later than on 22/03/2020, a registration fee of PLN 50 or 13 EUR should be paid using the [bilety.mtp.pl](http://bilety.mtp.pl) website.

### **§14**

Failure to pay the registration fee within the time specified in § 13 of the Regulations will result in the Participant not taking part in the Competition

## **TIME AND PLACE OF COMPETITION**

### **§15**

The competition will take place at the Poznań International Fair in Poznań.

### **§16**

Competition will last from 10 AM on March 27, 2020, until results are announced after 6 PM on March 29, 2020, in the Competition Area.

### **§17**

Time for each Participant qualified to the respective stage of the Competition to complete his run will be as follows:

- A. Up to 3 minutes - during the first stage of the Competition,
- B. Up to 3 minutes - during the finals.

### **§18**

1. The Competition Area consists of two zones:
  - A. The Competition zone, surrounded by metal barriers, covered with paving stones.
  - B. The Participants' zone, understood as a separate area for Participants to place their technical vehicles or service tents.

- a) Only Participants and their accompanying persons, the media, service and security personnel as well as the Event's organizers are allowed in the Participant's zone.
- b) Each Participant can be accompanied by three accompanying persons in the Participants zone. Each accompanying person has to be made known during the registration.
- c) The Organizer and service personnel of the Competition are not responsible for the items left in the Participant's zone.

## **PRIZES**

### **§19**

**Winers in the Competition** will get the following prizes:

1. 1st place – 1 400 euro in cash
2. 2nd place – 1 000 in cash
3. 3rd place – 700 euro in cash
4. 4th place – 200 euro in cash
5. 5th place – 100 euro in cash
6. 7th, 8th, 9th and 10th place – 50 euro in cash / each competitor.

### **§20**

Prizes are funded by the Organizer.

### **§21**

1. If necessary, the organizer will increase the value of the prize by the amount of tax. The player will not receive an increased amount. The organizer covers the costs of tax with the increased amount.
2. Cash prizes will be given to competitors after the results are announced on the day of the end of the competition. Each winner must collect the prize in person by signing an acknowledgment of receipt of the prize. If the Participant fails to collect the prize within 30 days of the end of the Competition, the Winner loses the right to the prize.

## **DETERMINING THE WINNERS**

### **§22**

1. To determine who has won the Competition, the Organizer will appoint following members for the Referee Commission :
  - A. Damian Bazaniak (Poland) – The Commission's Chairman
  - B. Adam Peschel (Czech Republic)
  - C. Rafał Pasierbek (Poland)
  - D. Daniel Kwiatkowski (Poland)

2. The qualification criteria for the Competition Finals as well as the selection criteria for the Competition Winners will be announced by February 14, 2020. The selection criteria for the Winners will be published on the [www.motorshow.pl](http://www.motorshow.pl) website and sent to the competitors by email to the email address indicated by the Participant in the application. The selection criteria for the Winners will also be available at the Organizer's office. After publication of the qualification criteria, each of the Participant may resign from participation in the Competition until March 15, 2020, by sending his resignation to the email address [stuntwarspoland@gmail.com](mailto:stuntwarspoland@gmail.com). In the event of resignation from participation in the Competition after payment of the registration fee, the fee is returned to the Player within 14 days from the date of resignation.
3. The decisions of the Referee Commission are final and binding for the Participants.
4. All questions during the Competition should be addressed to the Chairman of the Commission.

### **§23**

1. The Winners gain the right to collect the Prize.
2. The right to collect the Prize can not be transferred to another person.

### **§24**

The competition Winners will be announced on March 29, 2020 at 6 PM.

## **PERSONAL DATA OF THE PARTICIPANTS**

### **§25**

1. The Organizer is the administrator of the personal data.
2. By signing the application form, the Participant express his consent to processing his personal data for the purposes of the Competition. The Participant may consent to processing his personal data for other purposes by giving the relevant consents in the application form.
3. The personal data of the Participants will be processed for the purposes, in the scope and for the period necessary for the organization, conduct, and promotion of the Competition, selection of Winners, and receipt of prizes.
4. Participants have the right to: a) access their personal data, b) rectify their personal data, c) delete their personal data, d) limit the scope of their personal data processing, e) withdraw their consent for processing their personal data in the form of image at any time, which, however, will prevent them from participating in the Competition.

## **COMPLAINTS PROCEDURE**

### **§26**

All Complaints related to the course or results of the Competition should be submitted in writing, by registered mail, to the Organizer's address specified in § 4 of the Regulations with the note "Stunt Wars

Poznań Motor Show 2020”, within 14 days from the date of the announcement of the Competition results or by email to the address : info@mtp.pl within the same period or during the Event.

The complaint will be considered by the Organizer within 14 days of its receipt. The participant will be informed about the results of the complaint procedure - by mail in the case of a written complaint or an email in response to the complaint filed via email. Decisions of the Complaint Commission in the complaint procedure are final. Filing a complaint is a condition for pursuing claims against the Organizer.

#### **§27**

1. Each complaint should contain:
  - A. name and surname of the Participant filing the complaint.
  - B. Address and phone number of the Participant filing the complaint.
  - C. A detailed description and reasons for the complaint.

#### **§28**

Complaints will be considered by the Referee Commission acting as the Complaint Commission.

#### **§29**

All possible disputes arising from the competition will be solved by the parties. In the event of failure to reach an amicable settlement of any dispute, the dispute will be resolved by the relevant court.

### **FINAL PROVISIONS**

#### **§30**

Participants awarded in the Competition are not entitled to any additional remuneration beside the prizes provided for in the Regulations,.

#### **§31**

The Organizer does not bear any responsibility for any damages caused by providing false data or any other type of irregularity on the part of the Participant

#### **§32**

All descriptions of the Competition used in the advertising and promotional materials of the Competition are for general and informational purposes only. The Regulations in its entirety is the only binding document regarding the Competition.

### **§33**

The organizer reserves the right to make changes to these Regulations that do not violate the basic rules of the Competition. The participants will be notified about all changes via email sent to the address indicated in the application. Due to changes in the Regulations, the Participant has the right to resign from participation in the Competition within 5 days from the date of notification of the change, and to the refund of the registration fee, if the fee has been paid to the Organizer. Above mentioned resignation should be sent to the email address: [stuntwarspoland@gmail.com](mailto:stuntwarspoland@gmail.com) Refund of the registration fee will be made within 14 days from the date of resignation.

### **§34**

The participant joining the Competition accepts all the conditions of these Regulations and at the same time declares that he meets all the necessary conditions for participation.

### **§35**

All issues not covered by these Regulations are regulated by the Civil Code.
